



SENTRILOCK TRANSITION

Your lockbox service will soon be switching to SentriLock. As a Southern Oklahoma Board of REALTOR® (SOBR) Primary member, you will be receiving lockbox services through SOBR as always. Each association handles their lockbox contract differently. Here are som FAQs for SOBR's process.

TIMELINE

Monday, Oct. 9 - SentriLock will send activation emails.

Important - If your account is not activated, lockboxes **CANNOT** be programmed.

Monday, Oct. 23 - Member training email will be sent.

Monday, Oct. 30 - Training reminder email will be sent.

Friday, Nov. 3 - Lockboxes will arrive at the SOBR office.

Monday, Nov. 6 - Lockbox Pickup and Go Live Date.

KEYHOLDER FEE

Quarterly Sentri-Key fee \$56.75 (including tax).

SOBR is billing for the keyholder fee quarterly (prorated monthly for new keyholders) Autopayment shall be set up in your SOBR Membership Portal. Payment and billing will be one month prior to the quarterly cycle. If payment is not made by the last day of the month your service will be deactivated on the 1st of the month.

REFUND POLICY

No refunds given for lockbox services.

LOCKBOX EXCHANGE

SOBR will NOT charge for boxes.

The only fee you will pay is the Sentri-Key fee.

LOCKBOX RECLAIM

All SOBR SentriLock boxes will be **LEASED** to SOBR Primary members. This means they are **OWNED** by SOBR and not by individual REALTORS®.

SOBR can perform a recall/lockbox audit at any time. You will be required to bring boxes back to SOBR if a recall is issued. If boxes are not returned after 10 days, a \$140 lockbox replacement fee will be assessed.

OLD SUPRA BOXES

Brokerages will be able to ship old lockboxes at no charge via UPS. SentriLock will be sending emails with that process soon.

Please do not throw boxes in the trash as they are an environmental hazard.

ADDITIONAL LOCKBOXES

If additional lockboxes are requested, you may come to the SOBR office during business hours to pick up a lockbox (at no additional cost). Lockboxes will be assigned on Active/Pending residential listing counts. Inventory can be looked up in the MLS or bring a copy of a signed listing agreement with you.

INACTIVE LICENSEES

You are required to return all SentriLock lockboxes to SOBR as they are owned by the association. SOBR will charge \$140/box if boxes are not returned within 5 days of the status change.

MOVING ASSOCIATIONS

If you are moving your primary membership to another association, you will be required to return **ALL** SentriLock lockboxes to SOBR before SOBR will send a Letter of Good Standing to your new association. Once the lockboxes are returned, we will deactivate your Sentri-Key service. SOBR will then email a Letter of Good Standing to your new association.

SUPRA

Supra will be inactive on March 9, 2024

U L A A C C E S S

Access for unlicensed assistants are required to be added to an agent's SentriLock team to access their lockboxes. This provides the ability to remove the shackle, open the door, generate access codes and manage the lockboxes for the agent they are assisting. Assistants cannot access any lockbox key door of agents' whose teams they are not on, meaning they couldn't show property.
